<u>Parish Council Report – September</u>

Local Government Reorganisation

On 26 September, West Sussex councils submitted a joint Business Case and individual preference letters to central government, proposing their preferred models for local government reorganisation in the county. The proposals respond to the Government's ambition to develop alternative options to the current two-tier council system.

Horsham District Council, along with the other six district and borough councils, is stating its preference for a two unitary council model for West Sussex which would see the creation of a new Unitary Authority combining Horsham District Council, Crawley District Council and Mid Sussex District Council areas.

Leader of Horsham District Council, Cllr Martin Boffey, is now writing to the Government to ask ministers to consider the Council's preferred option.

He commented: "I am proud of the collaborative approach we have adopted with all participating West Sussex councils to arrive at this point. We feel this option, which was by far the most preferred option by residents and stakeholders in our engagement survey, will put residents first, giving you a more local focus on housing, social care and leisure and community services and creating a localised single point of contact for services which are most important to you."

"Having two smaller unitary councils in West Sussex will also create four seats on the board of the newly formed Mayoral Strategic Authority for West Sussex which will ensure that our communities are more fairly represented in regional decision making. This will better reflect the larger size of the West Sussex population compared to the populations of East Sussex and Brighton & Hove."

"This is a once-in-a-lifetime opportunity to deliver meaningful change and we cannot afford to miss it. In my view, only the two unitary council model can deliver on this ambition."

Local Plan Update

Horsham District Council calls for renewed scrutiny of Local Plan rejection

Horsham District Council has written a letter to Mr Luke Fleming, the Local Plan Inspector examining the Horsham District Local Plan, in response to his initial findings letter. The letter is available to view on the Local Plan Examination pages of the Council's website:

The letter requests that the examiner convene a further local plan hearing session to further examine the Council's compliance with the Duty to Co-operate. In its letter the Council explains that since the receipt of the Inspector's Initial Findings letter in April 2025, further evidence has become available which substantiates the Council's position that meaningful Duty to Co-operate discussions around unmet housing needs did take place between January and July 2024.

The letter follows a meeting of the Communities and Place Policy and Scrutiny Committee Meeting on 23 July 2025 which considered the context of imminent changing planning regulations that will repeal the Duty to Co-operate.

The Council will take account of the response it receives from the Inspectorate before any final decision is made to withdraw the Local Plan. A Cabinet Meeting was programmed for the 17 September 2025 to discuss the potential withdrawal of the Local Plan but this will be delayed until a response is received from the Planning Inspectorate.

Council launches judicial review against Secretary of State's planning decision

Horsham District Council has formally initiated a judicial review challenge against the Secretary of State's recent decision to grant outline planning permission for 800 homes at the Horsham Golf and Fitness site, Worthing Road, Horsham.

The Council originally refused the planning application on multiple grounds, including concerns over its unsustainable location and active travel options. Following a detailed legal review, and working in collaboration with Active Travel England, the Council is now contesting the decision on the basis that the government-appointed Planning Inspector made significant legal errors.

Key food waste facts*

- On average over 40% of waste in our Horsham District bins is food waste!
- Food that could have been eaten but gets thrown away in the UK (4.4 million tonnes) is worth around £17 billion. On average, this is around £1,000 per year for a household of four people.
- Associated emissions from food waste is equivalent to that generated by around one fifth of household cars on UK roads.
